# Good to know:

# All the links on the page are live and will take you to information regarding the FAFSA.

The FAFSA is a FREE, Federal document. Families should not have to pay to complete it. Use only the official site. Follow all the necessary steps and submit any documents requested by the college.

Even if you feel that your family will not qualify for any federal resources, complete the FAFSA anyway, as it is a requirement for many community-based scholarship applications. Some community-based applications will require that you answer a few questions about your FAFSA.

Year 2022 taxes are required to complete the 2024-2025 FAFSA.

Complete the FAFSA, as soon as possible, and by the college's designated priority date.

The FAFSA must be completed in all electronic format or all paper format- No Hybrid

The student and parent are required to request an <u>FSA ID</u> prior to completing the FAFSA, together. Families may do this now. Make sure to use different e-mail addresses for each account.

If students feel they do not qualify to complete the FAFSA, VASA may be an option. See below.

# **Steps of How the FAFSA Works in the College Process:**

Family Completes the FAFSA Form to include up to 20 colleges of interest Federal Government reviews the FAFSA to determine family's SAI (Student Aid Index) College-University will access the form after student's acceptance to the college College-University will determine a financial aid package based on student's FAFSA info (SAI) College-University sends family the financial aid award letter for review Family reviews all letters of financial aid and makes a decision Family informs the college of the student's intention to attend or not attend Family pays the required deposit to the college student will attend

## Federal Student Aid Estimator:

Families may want to use the <u>Federal Student Aid Estimator</u> before filling out the FAFSA<sup>®</sup> form to help them understand their options for paying for college or career school by providing them an early estimate of how much federal student aid they may be eligible for.

## VASA- Virginia Alternative State Aid Application:

The VASA is a Virginia State Aid application that is used as an alternative to the FAFSA. Students who do not qualify to complete the FAFSA are encouraged to complete the VASA, as it will be reviewed by the college to determine possible financial aid assistance.
